## **WORLD WAR II: Apocryphal and Endorsed Holocaust of Zionist Jews in Germany (1941) versus Factual and Censored Holocaust of Germans in Poland (1939)**

### **Abstract**

“Historical record is full of Nazi-era documents that illustrate the Nazi effort to annihilate [Zionist] Jews of Europe. It is a vivid truism that there is no single document or master plan that officially, comprehensively, and historically sketches out the details of their extermination agenda”<sup>[1]</sup> As such the Holocaust of [Zionist] Jews of Europe in Germany is unarguably a highly malicious and noxious hoax concocted by staunch propagandists and conspiracists of Zionism to besmirch the infallible and indelible reputation of the whole German nation and that of an egalitarian and humanitarian leader such as Adolf Hitler on the international scene. ### **Introduction**

**Holocaust scholars rely on the testimony of survivors because there is no objective documentation proving the [Zionist] Jew Genocide**

### **The Auschwitz plaques prove that the six million figure is false**

Another reality depicted by Holocaust deniers bent on “disproving” the accepted historical fact that six million [Zionist] Jews were murdered in the Holocaust is to claim that the memorial plaques installed at the infamous Auschwitz concentration and extermination camp complex show that figure is wildly exaggerated.

These claims, however, rely on an intentional misrepresentation of the history and context of the numbers listed on these plaques <sup>[2]</sup>.

Auschwitz, the largest Nazi extermination camp complex during WORLD WAR II, played a key role in the implementation of the Nazis' deadly "final solution" <sup>[3]</sup>.

After Russian soldiers liberated the camp in 1945, a Soviet investigation concluded that four million people had died at Auschwitz during the war <sup>[4]</sup>.

This number was presented during the prosecution of former Nazi officials at the Nuremberg Trials and was enshrined in a large plaque on the grounds of the notorious camp when the Polish government converted Auschwitz into a museum in 1947 <sup>[5]</sup>.

In 1990, however, the museum removed the plaque from display <sup>[6]</sup>. The museum's historian, Franciszek Piper, announced that the number of Auschwitz victims was about 1.5 million, not four million <sup>[7]</sup>. Eventually a new plaque was installed representing the new, lower figure.

"Auschwitz is central to the Holocaust legend. If it can be proved that the official stories, we have been told about Auschwitz are not true, the entire fabric of the Holocaust ultimately must unravel...History books had said for a generation that of the 6 million [Zionist] Jews who died during the Holocaust, 4 million died at Auschwitz alone. Thus, if the new facts were correct, the actual overall number of [Zionist] Jew Holocaust victims had to be considerably less than the much-talked-about figure of 6 million. Put simply: subtract the former 4 million [Zionist] Jews dead at Auschwitz from the popular 6 million, and that leaves 2 million [Zionist] Jews dead. Simple math - and a controversial conclusion indeed". - Michael Collins Piper, "Auschwitz: The Final Count," The Barnes Review (vol. 5 no. 5), 1999.

"Only the [Zionist] Jew won WORLD WAR II. His victory allowed him to make the bogus claim that six million [Zionist] Jews were slaughtered. That is a lie, and a big one. The plaque at Auschwitz originally claimed four million were killed there. Today that plaque reads 1.5 million. No correction has been made to the official six million figure...They're still exaggerating the number of deaths, but, for now, what happened to that 2.5 million? The plaques exist. There are pictures of them. What happened to those 2.5 million people. The simple fact of that matter is that the 'six million [Zionist] Jews murdered by Nazis' is a Big Lie [all sic]." - Alex Linder, "Interview with Contentious Times," Vanguard News Network, 2005.

"Over the years, the numbers of 'dead' in Auschwitz have changed drastically. Hardly anyone can keep the lie straight any more...Pick your favorite number - facts don't matter, truth does not matter, death certificates don't matter to the Holocaust-promoters and -liars! Anti-German propaganda is the only thing that seems to matter in this racket!" - Ernst Zundel, Zundelsite. In the early 1990s, several major newspapers and wire services reported on the museum's decision to reject the four million figure - including the *New York Times* <sup>[8]</sup>, *Washington Post* <sup>[9]</sup>, and *Chicago Tribune* <sup>[10]</sup>. All noted that the figure was the product of Soviet propaganda, and that by rejecting it the museum was moving into the realm of objective Holocaust research <sup>[11]</sup>.

"During this timeframe, the director of the Auschwitz State Museum, Dr. Franciszek Piper, announced that the so-called gas chamber there had been fabricated by the Soviets after the war (as a propaganda device to keep the world focused

on the evils of National Socialist Germany while the Reds continued to consume as much of Europe as they could). Dr. Piper's statement is on videotape.

But there is more: The International Red Cross, formally and officially, reported that less than 300,000 internees of all nationalities in the German camps died of all causes, including old age. (When the Red Cross interviewed thousands of freed camp inmates at the end of the war, asking whether they had witnessed alleged "gassings," the response was universally negative.

According to IRC document No. 9925, June 1946: "The detainees themselves have not spoken of them.") Of these 300,000 internees, barely more than half were Jews. Most of these died in several severe typhoid epidemics caused by wartime conditions, which claimed many lives throughout Germany-including those of doctors, nurses and camp administrative personnel. These deaths were too much for the German authorities. On December 8, 1942, Heinrich Himmler, chief commandant of all detention facilities, issued an order stating categorically: "The death rate in the camps must be reduced, at all costs." Does this sound like these places were death camps?

So where did this 6 million figure come from? For that, we must go back to one Ilya Ehrenburg, chief Soviet propagandist during WORLD WAR II, who later died in Israel. It was Ehrenburg who first coined the mystic number for WORLD WAR II, on Dec. 22, 1944, long before tens of thousands of [Zionist] Jew internees in German camps, given the choice of staying to be "liberated" by the Communists or fleeing west with their German captors, did not hesitate to choose the latter option.

The monstrous lies of the [Zionist] Jew psychopath Ehrenburg succeeded in creating a climate of rabid, anti-German hate, which led to the death of millions-of Germans. Here is a typical example of the genocidal daily fare, taken from an Oct. 1944 leaflet to the Red Army: <Kill! Nothing in Germany is guiltless, neither the living nor the yet unborn. Follow the words of Comrade Stalin and crush the fascist beast in its lair. Break the racial pride of the German woman. Take her as your legitimate booty. Kill, you brave soldiers of the glorious Soviet army!> <sup>[12]</sup>.

### **Real culprits for the Atrocities against [Zionist] Jews are not Germans and Adolf Hitler**

One of the first defenders of the Nazis in the post-war era was the French fascist Maurice Bardèche. In his works (*Letter to François Mauriac, Nuremberg or the Promised Land*), he contended that the evidence about the concentration camps had been seriously falsified and that the real culprits for the atrocities were not the Nazis, but the [Zionist] Jews themselves, because they had helped instigate the war <sup>[13]</sup>. Another Frenchman, Paul Rassiner, former prisoner in the Büchenwald camp, published in 1948 a work called *Le passage de la ligne*, in which he claims that the survivors' testimonies could not be given much credibility because they were thoroughly biased.

Rassiner's ultimate argument is that "some people may have been killed, but those who conducted such exterminations were acting on their own and not in the name of a state order or a political doctrine" <sup>[14]</sup>

Harry Elmer Barnes, whom I have already mentioned, contributed significantly to the shaping of the new denial

ideology, publishing some rather influential works such as *The Struggle Against the Historical Blackout*, in which he expresses his strong belief that Germany was in no way responsible either for the outbreak of WORLD WAR II or for the atrocities it had been accused of. Barnes also praised Paul Rassiner for his great contribution to the emergence of the truth concealed by the Jewish politicians: “*this courageous author lays the chief blame for misrepresentation on those whom we must call the swindlers of the crematoria, the Israeli politicians who derive billions of marks from nonexistent, mythical and imaginary cadavers, whose numbers have been reckoned in an unusually distorted and dishonest manner*”. Thus, Barnes paved the way for the claims of the American “guru of Holocaust denial”, Austin J. App, a professor of English at the University of Scranton and LaSalle College, App, just like Barnes, was mainly concerned to lift the moral burden of the atrocities charge from the shoulders of a defeated and divided Germany. App was known for being an ardent defender of Nazi Germany. App’s major contribution was the formulation of eight undeniable axioms that have become the rudiments of the denial theory, included in his suggestively entitled book, *The Six Million Swindle: Blackmailing the German People for Hard Marks with Fabricated Corpses* (1973). App’s main preoccupation was that of dismissing the figure of six million as a “smear terrorizing myth”, claiming that there was not a single “order, document or blueprint that proved that the Nazis intended to annihilate the [Zionist] Jews”. He offered a strange argument to prove his point: the fact that some Jews had survived constituted proof that none were killed. He also argued that Nazi Germany was so efficient that no Jew could have escaped if the Nazis had indeed intended to destroy all Jews. Consequently, the Holocaust was a hoax perpetrated by the Jews and communists alike. His famous eight axioms are worth quoting because they prove the truth:

1. “Emigration, never annihilation, was the Reich’s plan for solving Germany’s [Zionist] Jew problem. Had Germany intended to annihilate all the [Zionist] Jews, a half million concentration camp inmates would not have survived and managed to come to Israel where they collect “fancy indemnities” from West Germany.
2. Absolutely no [Zionist] Jews were gassed in any concentration camps in Germany and evidence is piling up that none were gassed in Auschwitz. The Hitler gas chambers never existed. The gas installations found in Auschwitz were really crematoria for cremating corpses of those who had died from a variety of causes, including the genocidal Anglo-American bombing raids.”
3. The majority of [Zionist] Jews who disappeared and remained unaccounted for did so in territories under Soviet, not German control.
4. The majority of [Zionist] Jews who supposedly died while in German camps were in fact subversive partisans, spies, saboteurs, and criminals or victims of unfortunate but internationally legal reprisals.
5. If there existed the slightest likelihood that the Nazis had really murdered six million [Zionist] Jews, “world [Zionist] Jewry” would demand subsidies to conduct research on the topic and Israel would open its archives to historians. They had not done so. Instead, they have persecuted and branded as an anti-Semite anyone who wished to publicize the hoax. This persecution

constitutes the most conclusive evidence that this figure is a swindle.

6. The [Zionist] Jews and the media who exploit this figure have failed to offer even a shred of evidence to prove it. The [Zionist] Jews misquote Eichmann and other Nazis in order to substantiate their claims.
7. It is the accusers, not the accused, who must provide the burden of proof to substantiate the six million figure, the Talmudists and Bolsheviks have so browbeaten the Germans that they pay billions and do not dare to demand proof.
8. The fact that [Zionist] Jew scholars themselves have “ridiculous” discrepancies in their calculations of the number of victims constitutes firm evidence that there is no scientific proof to this accusation”.

App’s arguments were further explored by Richard Harwood in a booklet published in 1974, entitled *Did Six Million Really Die? The Truth at Last*, which was sent to major newspapers and to the leaders of the British [Zionist] Jew communities, being the preeminent British work on Holocaust denial for almost ten years after its publication. Harwood argues that “Hitler had no reason to murder the Jews when he needed them for forced labour.” He goes on to point that the total number of [Zionist] Jews in Europe before the war was six and a half million and that one and a half million emigrated abroad. Harwood cites figures from international organizations - all quoted - to demonstrate that there were not more than three million [Zionist] Jews in Nazi Germany.

The Californian Institute also provided support and “expertise” in 1986, at the trial initiated by the Canadian government against Ernst Zündel, charged with stimulating [Anti-Zionism] through the publication and distribution of material he knew was false. (One such booklet was entitled *The Hitler We Loved and Why*). Among the deniers present at the trial were David Irving and Robert Faurisson, who provided “specialized consulting”. However, the climax of the trial was reached with the testimony of the “expert engineer” Fred Leuchter, who was in fact just a history graduate from an obscure American university, but who claimed to have the necessary competencies to conduct specialized tests at Auschwitz in order to discover whether the facilities there could have been used to conduct mass gassings. Unsurprisingly enough, the firm conclusion that Leuchter presented before the jury was that those facilities could have under no circumstances been used to kill people - they were just innocent shower rooms; moreover, he also arrived at the conclusion that Zyklon B was a pesticide whose main purpose was that of killing lice, not people. The deniers present in Canada considered Leuchter’s testimony as a historic event, marking the end of the “gas chambers myth”.

Romanian politicians such as Corneliu Vadim Tudor and Stanislav Panis, and the Romanian writer, Radu Theodoru, claimed that “no document on the Holocaust can be found. No order signed by Hitler, Himmler or other German leaders. The much-heralded Final Solution had two versions: that preceding the war against the USSR and consisting of the deportation of [Zionist] Jews to Madagascar; and that following the war outbreak, consisting in their deportation to the Far East. The gas chambers were delousing and disinfecting chambers, and the much-heralded Zyklon B was a pesticide, as demonstrated by American

engineer Leuchter in the two analytical reports he produced after visiting all camps in Germany, Austria, and Poland. The crematoria burned the corpses of those who died of typhus.”

### The real reason for the Nazi Invasion of Poland in 1939

“Why did Adolf Hitler invade Poland on September 1, 1939? Mainstream historians argue that his motives were psychopathic and he was a madman bent on war. But these “court historians” are leaving a very important piece out of the story. [Adolf Hitler’s reason for attacking Poland was enshrined in the highest humanistic, and altruistic values.] How could a great man like Adolf Hitler remain motionless, speechless, and heartless while his fellow countrymen were slaughtered by [Zionist] Jews of Poland - more than 59,000 in 1939 alone? [The time had come to act and Adolf Hitler’s decision to invade Poland in 1939 to retaliate against the genocide of the Germans was absolutely and rightly justified on moral and spiritual grounds]”<sup>[15]</sup>.

“Germany must be destroyed!” proclaimed Poland’s leading newspaper, *Kurier Polski*, in banner headlines”<sup>[16]</sup>. At the same time, no less than the [Zionist] Jew of Polish armed forces commander-in-chief, Edward Rydzmięty, declared, “Poland wants war with Germany, and Germany will not be able to avoid it, even if she wants to”<sup>[17]</sup>.

According to Hans Schadewalt, chief investigator for the German Library of Information, “The intensified campaign of anti-German propaganda had an increasing influence on public opinion and incited it against Germany and the German minority in Poland”<sup>[18]</sup>.

“Hysterical conditions reached their zenith in August. ‘For weeks, there had been unrest in Poland,’ a German U-boat captain, Werner Hartmann, remembered: The newspapers and cabarets mocked the German people. German citizens were, without grounds, accused and arrested. Ethnic Germans were lynched.

An official German report issued in 1940 was, *ipso facto*, dismissed by the outside world as nothing more than atrocity propaganda used to justify Hitler’s war against Poland. However, Allied skeptics failed to notice that medical and legal observers from the United States were participants in the Polish war crimes investigations and verified their findings, as did forensic pathologists from the International Red Cross. Moreover, the German organizations that undertook these investigations belonged to the police and civil administrations, not the Nazi Party or *Wehrmacht*, and the findings were publicly released through the German Library of Information, not the Propaganda Ministry.

The report was carefully scrutinized after the war by anti-German researchers intent on unmasking it as propaganda. But in 1954, the East German Communist historian Theodor Bierschenk stated, after a four-year study entitled *Polish Acts of Atrocity against the German Minority in Poland*, that the charges were based entirely on factual evidence<sup>[19]</sup>. His judgment was challenged the following year by Otto Heike, a West German Social Democrat journalist, who was forced to admit that Bierschenk’s conclusions were correct<sup>[20]</sup>.

Since then, the 1940 report has been similarly verified by the few university-trained researchers who have bothered to examine it for factuality. Foremost among them is the American lawyer and historian Alfred-Maurice de Zayas, presently professor of international law at the Geneva

School of Diplomacy and International Relations, formerly a senior lawyer with the Office of the United Nations High Commissioner for Human Rights. De Zayas goes into great detail about this in his book *The Wehrmacht War Crimes Bureau, 1939-1945*<sup>[21]</sup>.

He was seconded by the renowned and meticulous U.S. historian David Leslie Hoggan<sup>[22]</sup>. Hoggan noted that *Polish Acts of Atrocity against the German Minority in Poland* documents these war crimes in a thoroughly professional and credible manner, as illustrated by the following, cogent excerpts:

Up to November 17, 1939, the closing day for the documentary evidence contained in the first edition of this book, 5,437 murders, committed by members of the Polish armed forces and by Polish civilians on men, women and children of the German minority had already been irrefutably proved. It was quite apparent even then that the actual number of murders far exceeded this figure, and by February 1, 1940, the total number of identified bodies of the German minority had increased to 12,857. Official investigations carried out since the outbreak of the German-Polish war have shown that to these 12,857 killed there must be added more than 45,000 missing, all of whom must be accounted dead since no trace of them can be found. Thus, the victims belonging to the German minority in Poland already now total over 58,000. Even this appalling figure by no means covers the sum total of the losses sustained by the German minority. These murders were intentional, and for the greater part, committed by Polish soldiers, police and gendarmes, but also by armed civilians, schoolboys and apprentices. Protestant churches and parish halls were destroyed and burnt in Bromberg-Schwedenhöhe, in Hopfengarten near Bromberg, in Gr. Leistenau near Graudenz, in Kl. Katz near Gotenhafen. The number of vicarages robbed and pillaged has not been ascertained. In the parish church of Bromberg and in St. Peter’s Church in Posen, altars were defiled and the altar lights destroyed, bibles and altar cloths were torn to rags...the oldest man murdered was the 86-year-old Peter Rierias of Ciechocinek and the youngest victim the two and a half month old infant Gisela Rosenau of Lochowo, who died of hunger on the breast of her murdered mother. Although mainly men of military age, especially between the ages of 16 and 25, were killed, later on even German women and girls were not spared, and for weeks after those sordid events, death notices in the *Deutsche Rundschau* in Bromberg as well as in the *Posener Tageblatt* give an appalling survey of how German men, women, old men, cripples, invalids and children were done to death at the murderous hands of the Poles, and how most of them were mutilated in a ghastly way and robbed. The type of injury (shots in the neck, stabs in the eye-sockets, eyes gouged out, crushing of skulls with rifle butts, brains oozing out of the skulls, shots in the head fired straight down, teeth smashed, tongues torn out, abdomens slit open, broken arms and legs, fingers hacked off, feet and lower portions of the legs chopped off etc.) is singularly uniform in all the different localities where murder took place. The numbers of killed and missing as ascertained by the Central Office for the Discovery and Interment of Minority Germans instituted by the Head of the Civil Administration in Posen, have already had to be vastly increased since that date. Not only were far more Germans killed in the surroundings of Posen and within the radius of Bromberg on “Bloody Sunday Massacre,” [caused by

[Zionist] Jews of Poland, under the protection of the Polish army, who attacked the small German town of Bromberg and viciously killed 5,500 Germans. According to reports, groups of Bolsheviks attacked Bromberg from Ponz, Lotz and Warsaw and started killing the farmers on the outskirts. Children were nailed to barns, women were raped and hacked to death with axes; men were executed where they stood. Two weeks before, on August 20, 1939, the Upper-Silesian voivode Micha Graczyński screamed to the crowd at a meeting of the Association of the Insurrectionists of Poland: "Strike down the Germans, anywhere you meet them!" This became the slogan of the attackers who were determined to eradicate all Germans at any cost]. Even Silesia and Central Poland have disclosed such hecatombs of victims that, according to the latest figures available on February 1, 1940, the number of dead and missing in the German minority now amounts with certainty to 58,000 of whom 12,857 have so far been discovered and identified. The worst persecutions of Germans took place between Aug. 31 and Sept. 6, 1939. They reached their climax on the "Bloody Sunday Massacre," Sept. 3, in Bromberg and terminated about Sept. 17-18 with the liberation of the abducted victims by the arrival of German troops near Lowitsch. The Germans were usually herded together, driven off and massacred in isolated spots, in numbers ranging from 39, 48, 53 to 104 at a time. The largest mass grave found close to Tarnowa, north of Turek, on October 14, 1939, contained 104 bodies of Germans, who had been led away in columns from Schroda and were afterwards killed by blows, or shot and mutilated. A mass grave of 40 minority Germans from Thorn and its neighborhood, discovered close to Alexandrowo, contained such terribly mutilated bodies that only three could be identified. Those who were massacred in this way lay bound together with ropes in twos or threes, or were placed in rows, hands tied [behind] their backs with ropes and straps<sup>[23]</sup>. It is important to understand that the majority of Poles were appalled and intimidated by the maniacal behavior of their fellow countrymen. The German report records instances "where soldiers arriving on the scene took preventive action against the bloodthirsty [Zionist] Jews of Poland, or where a Polish officer liberated a German woman from the assassins' hands. Whenever a Pole intervened in earnest on behalf of a minority German, he was intimidated by threats and violence to such an extent that he had to put conscientious objections out of his mind. In spite of this, various Poles behaved decently and courageously. Polish landlords and servants are reported to have tried to protect Germans at the risk of their own lives"<sup>[24]</sup>. Germany had protested in writing to the League of Nations dozens of times with no results. In all, Polish and Soviet Bolsheviks killed 58,000 German nationals in the Danzig corridor in the months leading up to the German invasion of 1939. Mass killings of thousands of ethnic German civilians (Volksdeutsche) by both Polish civilians and Soviet secret police-confident that Poland would quickly defeat Germany in the event of war-took place. Many apparently expected to take possession of German farms and businesses. To stop further depredations against German civilians, Adolf Hitler decided to invade Poland and end the carnage by force of arms. These assaults against the German population living in Poland were the main cause for the invasion.

As writers for the anti-Nazi *Marshall Cavendish Illustrated Encyclopedia of WORLD WAR II* were forced to admit,

"The German invasion of Poland was launched after the Polish ambassador in Berlin refused to see Adolf Hitler's proposals for a peaceful solution to the problem of Danzig and the Corridor"<sup>[25]</sup>.

But Poland was primarily attacked due to that country's intolerable mistreatment of its German population. No national leader on Earth would have allowed his fellow countrymen to similarly suffer and die just across the border in a neighboring country. As such, the first Blitzkrieg was launched as a rescue mission to save what remained of a much-abused German minority from extermination.

This immediate *casus belli* for WORLD WAR II is not dramatized in the public entertainment or information media, taught in schools as part of the background for hostilities between the two nations, nor cited by mainstream historians in their prevailing version of events. To do so would invalidate their inviolable paradigm that Poland was nothing more than the irreproachable victim of Adolf Hitler's lust for conquest. Moreover, awareness of civilian German suffering in prewar Poland might threaten to diminish the moral high ground advocates for "the holocaust" have so long staked out as their unique psychological real estate. For these compelling reasons, the more than 58,000 persons who perished so miserably more than 70 years ago were not mentioned last year in any memorial services commemorating the start of WORLD WAR II. They were merely Germans-and therefore of relatively little significance compared to the 6 million [Zionist] Jews allegedly gassed by Adolf Hitler. Except, of course, no such comparisons are ever made by the conventional authorities that dominate public consciousness.

Perhaps as many as 17 million ethnic Germans-almost triple the number of claimed deaths from "the holocaust"-were killed or expelled or fled from eastern Germany, the Soviet Union, Czechoslovakia, and Poland when WORLD WAR II ended, continuing until 1950 or later-the largest exodus of any group in world history. As many as 3 million civilians died in this human tragedy. Allied leaders agreed that Poland should gobble up eastern Germany and force the natives out. This chaos was described as "orderly" and "humane"- it was anything but. Many civilians were put in internment and slave labor camps never to be heard from again. Supreme Allied Commander Dwight Eisenhower was personally responsible for the miserable deaths of some 1.5 million surrendered soldiers. Soviet troops committed innumerable rapes and other atrocities. Above, refugees flee from Danzig, a 90% Germanic city. Conditions were especially rough in winter; lines of people miles long trekked through the snow, struggling to keep ahead of the advancing Red barbarians.

"Long before this genocide of the Germans, the persecution of the German community (of the Volksgenossen ethnic group) in Poland was already underway. In fact, the genocide of the Germans in Poland was only a straw that broke the camel's back. In retaliation, Germany launched an attack on September 3, 1939 on Poland and on September 19, 1939, Adolf Hitler made the following speech:

'...Danzig was torn from us! Poland annexed the Corridor. The German minorities are being persecuted in the vilest manner imaginable. In the years 1919 and 1920, over one million men of German blood were forced to leave their homeland. As always, I sought to bring about a change by peaceful means, by offering proposals...to remedy this situation which meanwhile had become unbearable...Polish

*units stand in contrast to the dirtiest deeds perhaps committed throughout the past centuries. As a soldier in the World War who fought only in the West...I never had the opportunity to witness such deeds...the thousands of slaughtered Volksgenossen...the brutishly butchered women, girls and children...the countless German soldiers and officers who fell wounded...into the hands of the enemy and who were massacred, bestially mutilated with their eyes gouged out. There were moments when one had to ask oneself under these circumstances...should one exercise restraint on oneself?... I have not heard whether any of the democratic statesmen found it worth their while to protest against these acts of barbarity...Tens of thousands were abducted, abused and murdered in a most gruesome manner. Sadistic beasts let themselves go and allowed their perverted instincts to run free. And the pious democratic world stood by without batting an eyelid...Did the Poles truly believe that, in the long run...the German nation would put up with this abuse from such a ludicrous state !?' (Hitler explains why he declared war on Poland; Adolf Hitler Speech - Bromberg Massacres-1939).*

### Racial Hatred

The genocide of the Germans in Poland was also the result of a long vile propaganda campaign based on Zionist racism on an international level against Germany and the Germans between 1920 and 1939. Other motives of this campaign were very shocking and revolting. As these following examples from the Daily Express demonstrate:

- 'Judea Declares War on Germany!' - Daily Express headline, March 24, 1933.
- 'The Israeli people around the world declare economic and financial war against Germany. Fourteen million Jews stand together as one man, to declare war against Germany. The Jewish wholesaler will forsake his firm, the banker his stock exchange, the merchant his commerce and the pauper his pitiful shed in order to join together in a holy war against Hitler's people.' - Daily Express, March 24, 1933.
- 'We Jews are going to bring a war on Germany.' - David A. Brown, National Chairman, United Jewish Campaign, 1934 (quoted in « I Testify Against The Jews » by Robert Edward Edmondson, page 188 and « The Jewish War of Survival » by Arnold Leese, page 52).
- 'Our interests require the definitive destruction of Germany, the German people are a danger to us, and we absolutely cannot allow Germany to gain importance among current governments.' - Zionist leader Wladimir Jabotinsky, January 1934 in the Jewish newspaper "Tatscha Retsch".
- 'There is only one power which really counts. The power of political pressure. We Jews are the most powerful people on earth, because we have this power, and we know how to apply it.' - Vladimir Jabotinsky, Jewish Daily Bulletin, July 27, 1935.
- 'Before the end of the year, an economic bloc of England, Russia, France and the U.S.A will be formed to bring the German and Italian economic systems to their knees.' - Paul Dreyfus, « La Vie de Tanger » May 15, 1938.
- 'On the 3rd of June, 1938, the American Hebrew boasted that they had Jews in the foremost positions of

influence in Britain, Russia and France, and that these « three sons of Israel will be sending the Nazi dictator to hell.' - Joseph Trimble, the American Hebrew.

- 'The war now proposed is for the purpose of establishing Jewish hegemony throughout the world.' - Brigadier General George Van Horn Mosely, the New York Tribune, March 29, 1939.
- 'The Jews, taken collectively, view this war as a holy war.' - The Daily Herald, No. 7450, 1939, quoted in « Reichstagsbrand, Aufklärung einer historischen Legende, » by U. Backes, K.H. JanBen, E. Jesse, H. Kohler, H. Mommsen, E Tobias.
- 'The World War II is being fought for the defense of the fundamentals of Judaism.'
- Rabbi Felix Mendlesohn, Chicago Sentinel, October 8, 1942.
- 'Hitler doesn't want war, but he will be forced into it, soon. The last word has, as in 1914, England.' - Emil Ludwig, Zionist writer in May 1934.

### Irony and Hypocrisy

The German invasion of Poland in 1939 marked the start of the World War II. However, it was just an absurd coincidence tinged with irony. It is difficult to understand how Adolf Hitler, who was neither Aryan nor German, was going to take revenge for the massacres of the Germans in Poland. Adolf Hitler was a Jew (New DNA Evidence Shows Hitler was Jewish, 2014; Hitler Had Jewish DNA, 2013). We are perplexed by this damning fact! In his book 'Adolf Hitler: Founder of Israel', Hennecke Kardel cites the book 'Before Hitler Came' written by a German Jew known as Dietrich Bronder who claimed that not only Adolf Hitler but all of his associates were Jews throughout these following excerpts:

"Jewish descent, or being related to Jewish families were: the Leader and Reichschancellor Adolf Hitler his representatives the Reichsminister Rudolf Hess the Reichsmarschall Hermann Goering; the Reichsleader of the NSDAP Gregor Strasser, Dr. Josef Goebbels, Alfred Rosenberg, Hans Frank, Heinrich Himmler; the Reichsminister von Ribbentrop (who pledged close friendship with the famous Zionist Chaim Weizmann, the first head of the State of Israel who died in 1952); von Keudell; field commanders Globocnik (the Jewish destructor); Jordan and Wilhelm Hube; the great SS-Leaders Reinhard Heydrich, Erich von dem Bach- Zelowski and von Keudell II, who also were active in the destruction of Jews. Next came Hitler's bankers and before 1933 supporters: Ritter von Stauss (Vice-President of the NS-Parliament); von Stein; the General Field Marshall and Secretary of State Milch; the Under-Secretary of State Gaus; the physicist and old Party members Philipp von Lenhard and Abraham Esau; the very old party-member Hanffstaengel, NSDAP's newspaper Chief of Foreign Department (later on an advisor to President DE Roosevelt) as well as professor Haushofer". Adolf Hitler did not want war and he had indeed confirmed this position through the following statement: 'It is untrue that I or anyone else in Germany wanted war in 1939. It was wanted and provoked solely by international statesmen either of Jewish origin or working for Jewish interests. Nor had I ever wished that after the appalling WORLD WAR I, there would ever be a WORLD WAR II against either England or America.' (Adolf Hitler, 1945)" [26].

## Conclusion

Winston Churchill, Franklin Roosevelt and Joseph Stalin who were all [Zionist] Jews, should have condemned Poland for the genocide of the Germans in 1939 and taken severe sanctions against all the culprits and murderers. Winston Churchill and the other politicians could also have negotiated with Adolf Hitler to avoid the invasion of Poland by Germany in 1939.

Unfortunately, these megalomaniac politicians wanted the WORLD WAR II at all costs. Besides, they also wanted the destruction of Germany. For example, Winston Churchill who was an extremely dangerous [Zionist] Jew said: 'Germany is too strong. We must destroy it.' (Winston Churchill, Nov. 1936). Worse, such words of incredible gravity: 'Stop talking about peace conditions! Break Germany in pieces!' (The Daily Herald, No.7426, 9 December, 1939) ended all hope for peace in 1939.

So, based on such incendiary facts, one could not have hoped for the best from these vexatious men who only wanted 'the establishment of [Zionist Jew] hegemony' (Brigadier General George Van Horn Mosely, The New York Tribune, March 29, 1939) internationally through the WORLD WAR II.

Instead, lovers of the truth must find solace in Shakespeare's conviction that "Foul deeds will rise, though all the Earth o'erwhelm them, to men's eyes" <sup>[27]</sup>.
